#### **Opening Remarks**

#### Arnold Drung, Chairman, Lutheran Church-Canada, Board of Directors

Good afternoon and thank you for participating in this special convention. I pray that God has been keeping each of you and your loved ones safe through the pandemic.

2020 has been a year of many firsts, most of them unwelcome. Today's session is to deal with the challenges that have been brought to our Synod due to the pandemic. When our board met via conference call in February, we certainly didn't think that we would be facing a dramatic change in circumstances in a very short time period. Planning work was already underway for the 2021 Synod convention with a site chosen and preliminary arrangements made. With the declaration of the pandemic and ensuing restrictions, decisions regarding the convention were required. The LCC Board had a lengthy discussion regarding potential options. These included forging ahead with the 2021 convention as previously contemplated, moving to an on-line convention in 2021 or moving the convention to 2022 in a traditional format. While each of these had some merit, the overwhelming opinion of board members was that the convention needed to be in a face-toface format. This would realistically have to take place in 2022, assuming that the world will have moved beyond the pandemic by then.

A review of the LCC by-laws and discussion with the Committee on Constitutional Matters and Structure quickly led to the conclusion that postponing the convention would require a change to those by-laws and that could only happen with the special convention that we are undertaking today. While there has been significant work to make this happen, the Synod has strived to conduct its affairs in a way that is open, honest and with maximum integrity – as the Lord would have us do – and we believe that today's event achieves that standard.

I do want to take a moment to acknowledge the work of Synod staff over the past 7 months as they have dealt with all of the challenges of pandemic work arrangements as well as planning for this special convention. We are blessed with a wonderful, committed team and we pray that God will continue to be their constant helper as they go about their tasks.

I also want to acknowledge and thank the members of our Board of Directors for their ongoing service, particularly with the many virtual meetings that have been held during the pandemic. Should today's resolution be passed, all will continue to serve for the additional year with one exception. Cindy Sholdice, who has served on the board since 2014 and is a member of St. James, Winnipeg has recently been appointed a provincial court judge by the Province of Manitoba and as a result, will have to relinquish her LCC board membership. We extend our congratulations to her on this significant achievement, wish her well in her new position and thank her for her service to the church. The board will work to fill the vacancy in the coming months.

Thank you again for being will to serve the members of the Synod today and I wish each of our delegates God's guidance as you deal with the decisions before you.

#### **Opening Remarks**

#### Rev. William R. A. Ney, Chairman, Lutheran Church-Canada Commission on Constitutional Matters and Structure

#### Introduction

Thank you, President Teuscher, for giving the CCMS this opportunity to review and clarify a number of rulings recently made as requested by yourself, the Synodical Business Manager, Mr. Dwayne Cleave, and the Board of Directors of LCC.

I want to begin by stating that the CCMS has not and does not take any position on whether or not this Special Convention should or should not be taking place, nor has the CCMS taken any position on the Resolution that this Special Convention will be asked to vote upon, that is to change Bylaw 9.01 of the Statutory Bylaws. The Commission was asked only to rule on a number of specific questions.

It should be noted that in every decision made by the CCMS, two lawyers were consulted, Mr. Gary Gilmore who sits on the CCMS as a member and the Synod's Lawyer, Celia Valel of MLT Aikins LLP who serves as our Synodical Lawyer and is located in Winnipeg, MB. It should also be noted that many hours were spent on researching, discussing, debating and in prayer prior to any ruling being made. So, here are the five questions that were asked of the Commission.

#### 1. Do the Bylaws of LCC allow Lutheran Church-Canada to hold a "virtual Convention"?

The CCMS, after researching the Bylaws of Synod concluded that there is neither any permission given nor any prohibition for holding a "virtual convention" contained therein.

However, based primarily upon Bylaw 2.77 which permits participation via telephonic or electronic communication facilities in meetings of committees, commissions, or other bodies or entities established under the Synodical Bylaws, and based upon common practice in Canada, especially since the advent of the Corona Virus, the CCMS ruled that it is possible to hold a "virtual Convention" where all individuals participating by such means have proper access to the meetings of the Convention and can fully participate in it.

# 2. Can the time frame for a Synodical Convention be extended beyond the 4 years mandated by Statutory Bylaw 9.01?

After researching the Statutory Bylaws, Constitution, and Synodical Bylaws the CCMS determined and ruled that there is no provision to be able to extend the holding of a Convention beyond 4 years in the current Handbook of the Synod (2017).

# 3. Could a Special Convention be convened in order to amend Bylaw 9.01 with language that would allow for the extension of the 4 year time period between Conventions?

The CCMS ruled that a Special Convention could be called according to the provisions set forth in Bylaw 9.09, 9.10, and 9.11 of the Statutory Bylaws. And amendments may be made to the Statutory Bylaws, the Synodical Constitution or the Synodical Bylaws by the Convention (ref. Bylaw 9.06 of the Statutory Bylaws). Additionally, Synodical Bylaw 20.01

states that repeal or amendment of the Bylaws may be made by a 2/3 majority of the votes cast by the delegates at a Convention.

# 4. Who would serve as delegates to the Special Convention?

There was much discussion and debate on this question. The reality of not having held a Convention under the provisions of the new 2017 Handbook which requires a lay delegate and a pastoral delegate from every congregation or parish within the Synod, posed a difficult dilemma. This was because Statutory Bylaw 9.13 (2017 Handbook) clearly states that "those eligible to attend and vote at a Special Convention shall be those delegates in office at the time of the preceding Convention..."

Those delegates in office at the time of the 2017 Convention were chosen under the old rules and consist of laypersons and pastors elected by their Circuits. There thus appeared to be a conflict between the requirement of 9.13 and the requirement of congregational representation also contained in the 2017 Handbook.

As you might imagine the discussions were long and hard on this issue and finally the CCMS ruled that 9.13 must be respected since we are still in the transition period between the old and new Handbook regulations. This opinion was also supported fully both by the CCMS Lawyer and the Synodical Lawyer.

Therefore, the CCMS ruled that those delegates who attended the 2017 Convention would be the delegates for the Special Convention.

5. Can the term limits (4 yrs.) of elected and appointed officials be extended to the next in-person Convention in 2022 if there is an affirmative vote to extend the 4 years between Conventions to 5 years at the Special Convention?

Once again this was a very difficult question to answer because the special circumstances of a global pandemic was not contemplated in the writing and adoption of the 2017 Handbook, and therefore there were no interim rules set in place. Many hours of research and discussion and consultation with the Synodical Lawyer resulted in the CCMS ruling that if the Special Convention voted to extend the Convention time period for another year due to the special pandemic circumstances, then the current officers, boards and commission members' terms of service could be extended until the next Convention a year later.

The CCMS based its opinion primarily on Synodical Bylaw 10.01(a) & (b) which states that "An officer in office at the time this Bylaw comes into force shall continue in that office until that individual's successor takes office" but also indicates that "the term of office of each officer shall be deemed to expire on the 15<sup>th</sup> day of January, 2018" and that "the Convention shall proceed to elect officers to take office as of the 15<sup>th</sup> day of January 2018."

Given the special circumstances in which we found ourselves and given the fact that the current officers did not take office officially until January 18, 2018, their service and term of office will, in fact, be 4 years in January of 2022. Thus, the CCMS ruled that the current officers' terms of service could be extended if this Convention votes to extend the time of the next Convention to 2022. This ruling was also supported by the Synodical Lawyer who additionally stated that according to Synodical Bylaw 2.104 "the Commission is given considerable latitude with respect to interpreting the constating documents."

#### **Conclusion:**

I hope that this brief excursus into some of the thinking and reasoning of the Commission in deliberating on these issues has been helpful to you in being able to understand how and why we made the rulings requested.

May God bestow His blessing upon us as we seek to do His will and carry on our work together for Christ Jesus as members of Lutheran Church-Canada.

#### Call to Order - President Timothy Teuscher

The Special Convention was called to order at 11:16 am (CDT)

#### **Zoom Introduction—Technical Procedures for the Special Convention**

A brief tutorial, led by Paul Dueck, River City AV taught Convention Delegates how to vote "Yes" or "No" during the Convention, as well as "How to raise your hand," virtually if Convention Delegates wished to speak to a motion during the meeting. An opportunity was provided for the Delegates to practice each of these procedures, and once it was determined that everyone understood how to proceed—President Teuscher continued with the agenda.

#### **Registration Committee Report – Grace Henderson, Chairperson**

- 74 Voting Delegates in attendance
- 21 Non-voting persons in attendance

According to Statutory Bylaw 9.07 of the 2017 Handbook of Lutheran Church-Canada a quorum for Convention shall consist of at least 25% of eligible delegates. There are 98 eligible delegates, and with 74 eligible delegates in attendance, quorum has been satisfied.

#### **Adoption of Special Standing Rules**

- 1. A delegate wising to address the convention should electronically enter the appropriate queue, and, when recognized by the chair, state his or her name. The delegate shall also state the name of the circuit and region or administrative unit he or she represents.
- 2. A three-minute limitation shall be applied to all who speak 'from the floor.'
- 3. Business of the special convention shall be limited to that which arises from the overture submitted by the Board of Directors and shall come before the convention for a decision only through the appropriate resolutions committee (Synodical Bylaw 2.19 f).
- 4. The whereas sections shall be considered an integral part of a resolution and any action pertaining to the resolution applies to all its parts.
- 5. If substitute motions are offered, they shall be handled according to Robert's Rules of Order.
- 6. Unless covered by these Standing Rules of the convention; parliamentary procedures shall be governed by Robert's Rules of Order, Newly Revised, latest edition.

# TO AMEND STATUTORY BYLAW 9.01 OF THE 2017 HANDBOOK OF LUTHERAN CHURCH-CANADA

WHEREAS the uncertainties and restrictions resulting from the present COVID19 pandemic bring into question the wisdom or even the possibility of holding an in-person Convention of Lutheran Church–Canada, scheduled for June of 2021; and

where the purpose of holding a Convention is not simply for conducting the business of the church: the elections to various offices and positions, making amendments to the Handbook, taking action on overtures and reports, and so on, but is also an important opportunity to physically gather together as contemplated in Synodical Bylaw 2.01: "The Convention shall afford an opportunity for worship, nurture, inspiration, fellowship, and the communication of vital information"; and

**WHEREAS** changing the June 2021 Convention from an in-person to a virtual or online Convention would result in pastor and lay delegates being unable to physically gather together for a period of eight years; and

**WHEREAS** postponing the June 2021 Convention to 2022 requires a change to Statutory Bylaw 9.01 of the 2017 Handbook of LCC; therefore be it

RESOLVED that Statutory Bylaw 9.01, as it currently reads: "A Convention shall be held every four years at a time and place determined by the Board" be amended to read: "A Convention shall be held every four years at a time and place determined by the Board. The Convention may, however, be postponed due to extraordinary events (acts of God, war, terrorism, government regulations, disaster, strikes, civil disorder, pandemic, etc.). In such a case, the Convention is to be held as soon as practicable"

**Motion:** The Resolutions Committee moves the adoption of Resolution 20.1.01 to amend Statutory Bylaw 9.01 of the 2017 Handbook of Lutheran Church-Canada.

Since this motion is brought forward by the Resolution Committee, it does not require a second.

During the vote, a 2/3 majority is required to pass, since it is a change in Bylaw.
